

In the Senate of the United States,

December 8, 2006.

Resolved, That the bill from the House of Representatives (H.R. 6164) entitled “An Act to amend title IV of the Public Health Service Act to revise and extend the authorities of the National Institutes of Health, and for other purposes.”, do pass with the following

AMENDMENT:

Strike out all after the enacting clause and insert:

1 ***SECTION 1. SHORT TITLE.***

2 *This Act may be cited as the “National Institutes of*

3 *Health Reform Act of 2006”.*

1 **TITLE I—NIH REFORM**

2 **SEC. 101. ORGANIZATION OF NATIONAL INSTITUTES OF**
3 **HEALTH.**

4 (a) *IN GENERAL.*—Section 401 of the Public Health
5 Service Act (42 U.S.C. 281) is amended to read as follows:

6 **“SEC. 401. ORGANIZATION OF NATIONAL INSTITUTES OF**
7 **HEALTH.**

8 “(a) *RELATION TO PUBLIC HEALTH SERVICE.*—The
9 National Institutes of Health is an agency of the Service.

10 “(b) *NATIONAL RESEARCH INSTITUTES AND NATIONAL*
11 *CENTERS.*—The following agencies of the National Insti-
12 *tutes of Health are national research institutes or national*
13 *centers:*

14 “(1) *The National Cancer Institute.*

15 “(2) *The National Heart, Lung, and Blood Insti-*
16 *tute.*

17 “(3) *The National Institute of Diabetes and Di-*
18 *gestive and Kidney Diseases.*

19 “(4) *The National Institute of Arthritis and*
20 *Musculoskeletal and Skin Diseases.*

21 “(5) *The National Institute on Aging.*

22 “(6) *The National Institute of Allergy and Infec-*
23 *tious Diseases.*

24 “(7) *The National Institute of Child Health and*
25 *Human Development.*

1 “(8) *The National Institute of Dental and*
2 *Craniofacial Research.*

3 “(9) *The National Eye Institute.*

4 “(10) *The National Institute of Neurological Dis-*
5 *orders and Stroke.*

6 “(11) *The National Institute on Deafness and*
7 *Other Communication Disorders.*

8 “(12) *The National Institute on Alcohol Abuse*
9 *and Alcoholism.*

10 “(13) *The National Institute on Drug Abuse.*

11 “(14) *The National Institute of Mental Health.*

12 “(15) *The National Institute of General Medical*
13 *Sciences.*

14 “(16) *The National Institute of Environmental*
15 *Health Sciences.*

16 “(17) *The National Institute of Nursing Re-*
17 *search.*

18 “(18) *The National Institute of Biomedical Im-*
19 *aging and Bioengineering.*

20 “(19) *The National Human Genome Research*
21 *Institute.*

22 “(20) *The National Library of Medicine.*

23 “(21) *The National Center for Research Re-*
24 *sources.*

1 “(22) *The John E. Fogarty International Center*
2 *for Advanced Study in the Health Sciences.*

3 “(23) *The National Center for Complementary*
4 *and Alternative Medicine.*

5 “(24) *The National Center on Minority Health*
6 *and Health Disparities.*

7 “(25) *Any other national center that, as an*
8 *agency separate from any national research institute,*
9 *was established within the National Institutes of*
10 *Health as of the day before the date of the enactment*
11 *of the National Institutes of Health Reform Act of*
12 *2006.*

13 “(c) *DIVISION OF PROGRAM COORDINATION, PLAN-*
14 *NING, AND STRATEGIC INITIATIVES.—*

15 “(1) *IN GENERAL.—Within the Office of the Di-*
16 *rector of the National Institutes of Health, there shall*
17 *be a Division of Program Coordination, Planning,*
18 *and Strategic Initiatives (referred to in this sub-*
19 *section as the ‘Division’).*

20 “(2) *OFFICES WITHIN DIVISION.—*

21 “(A) *OFFICES.—The following offices are*
22 *within the Division: The Office of AIDS Re-*
23 *search, the Office of Research on Women’s*
24 *Health, the Office of Behavioral and Social*
25 *Sciences Research, the Office of Disease Preven-*

1 *tion, the Office of Dietary Supplements, the Of-*
2 *ice of Rare Diseases, and any other office lo-*
3 *cated within the Office of the Director of NIH as*
4 *of the day before the date of the enactment of the*
5 *National Institutes of Health Reform Act of*
6 *2006. In addition to such offices, the Director of*
7 *NIH may establish within the Division such ad-*
8 *ditional offices or other administrative units as*
9 *the Director determines to be appropriate.*

10 *“(B) AUTHORITIES.—Each office in the*
11 *Division—*

12 *“(i) shall continue to carry out the au-*
13 *thorities that were in effect for the office be-*
14 *fore the date of enactment referred to in*
15 *subparagraph (A); and*

16 *“(ii) shall, as determined appropriate*
17 *by the Director of NIH, support the Divi-*
18 *sion with respect to the authorities described*
19 *in section 402(b)(7).*

20 *“(d) ORGANIZATION.—*

21 *“(1) NUMBER OF INSTITUTES AND CENTERS.—In*
22 *the National Institutes of Health, the number of na-*
23 *tional research institutes and national centers may*
24 *not exceed a total of 27, including any such institutes*
25 *or centers established under authority of paragraph*

1 (2) or under authority of this title as in effect on the
2 day before the date of the enactment of the National
3 Institutes of Health Reform Act of 2006.”.

4 (b) *ADDITIONAL PROVISIONS REGARDING ORGANIZA-*
5 *TION.—Section 401 of the Public Health Service Act, as*
6 *added by subsection (a) of this section, is amended—*

7 (1) *in subsection (d), by adding at the end the*
8 *following:*

9 “(3) *REORGANIZATION OF OFFICE OF DIREC-*
10 *TOR.—Notwithstanding subsection (c), the Director of*
11 *NIH may, after a series of public hearings, and with*
12 *the approval of the Secretary, reorganize the offices*
13 *within the Office of the Director, including the addi-*
14 *tion, removal, or transfer of functions of such offices,*
15 *and the establishment or termination of such offices,*
16 *if the Director determines that the overall manage-*
17 *ment and operation of programs and activities con-*
18 *ducted or supported by such offices would be more ef-*
19 *fectively carried out under such a reorganization.*

20 “(4) *INTERNAL REORGANIZATION OF INSTITUTES*
21 *AND CENTERS.—Notwithstanding any conflicting pro-*
22 *visions of this title, the director of a national research*
23 *institute or a national center may, after a series of*
24 *public hearings and with the approval of the Director*
25 *of NIH, reorganize the divisions, centers, or other ad-*

1 *ministrative units within such institute or center, in-*
 2 *cluding the addition, removal, or transfer of functions*
 3 *of such units, and the establishment or termination of*
 4 *such units, if the director of such institute or center*
 5 *determines that the overall management and oper-*
 6 *ation of programs and activities conducted or sup-*
 7 *ported by such divisions, centers, or other units would*
 8 *be more efficiently carried out under such a reorga-*
 9 *nization.”; and*

10 (2) *by adding after subsection (d) the following:*

11 “(e) *SCIENTIFIC MANAGEMENT REVIEW BOARD FOR*
 12 *PERIODIC ORGANIZATIONAL REVIEWS.—*

13 “(1) *IN GENERAL.—Not later than 60 days after*
 14 *the date of the enactment of the National Institutes of*
 15 *Health Reform Act of 2006, the Secretary shall estab-*
 16 *lish an advisory council within the National Insti-*
 17 *tutes of Health to be known as the Scientific Manage-*
 18 *ment Review Board (referred to in this subsection as*
 19 *the ‘Board’).*

20 “(2) *DUTIES.—*

21 “(A) *REPORTS ON ORGANIZATIONAL*
 22 *ISSUES.—The Board shall provide advice to the*
 23 *appropriate officials under subsection (d) regard-*
 24 *ing the use of the authorities established in para-*
 25 *graphs (2), (3), and (4) of such subsection to re-*

1 *organize the National Institutes of Health (re-*
2 *ferred to in this subsection as ‘organizational au-*
3 *thorities’). Not less frequently than once each 7*
4 *years, the Board shall—*

5 *“(i) determine whether and to what ex-*
6 *tent the organizational authorities should be*
7 *used; and*

8 *“(ii) issue a report providing the rec-*
9 *ommendations of the Board regarding the*
10 *use of the authorities and the reasons under-*
11 *lying the recommendations.*

12 *“(B) CERTAIN RESPONSIBILITIES REGARD-*
13 *ING REPORTS.—The activities of the Board with*
14 *respect to a report under subparagraph (A) shall*
15 *include the following:*

16 *“(i) Reviewing the research portfolio of*
17 *the National Institutes of Health (referred*
18 *to in this subsection as ‘NIH’) in order to*
19 *determine the progress and effectiveness and*
20 *value of the portfolio and the allocation*
21 *among the portfolio activities of the re-*
22 *sources of NIH.*

23 *“(ii) Determining pending scientific*
24 *opportunities, and public health needs, with*

1 *respect to research within the jurisdiction of*
2 *NIH.*

3 “(iii) *For any proposal for organiza-*
4 *tional changes to which the Board gives sig-*
5 *nificant consideration as a possible rec-*
6 *ommendation in such report—*

7 “(I) *analyzing the budgetary and*
8 *operational consequences of the pro-*
9 *posed changes;*

10 “(II) *taking into account histor-*
11 *ical funding and support for research*
12 *activities at national research insti-*
13 *tutes and centers that have been estab-*
14 *lished recently relative to national re-*
15 *search institutes and centers that have*
16 *been in existence for more than two*
17 *decades;*

18 “(III) *estimating the level of re-*
19 *sources needed to implement the pro-*
20 *posed changes;*

21 “(IV) *assuming the proposed*
22 *changes will be made and making a*
23 *recommendation for the allocation of*
24 *the resources of NIH among the na-*

1 *tional research institutes and national*
2 *centers; and*

3 “(V) *analyzing the consequences*
4 *for the progress of research in the areas*
5 *affected by the proposed changes.*

6 “(C) *CONSULTATION.—In carrying out sub-*
7 *paragraph (A), the Board shall consult with—*

8 “(i) *the heads of national research in-*
9 *stitutes and national centers whose directors*
10 *are not members of the Board;*

11 “(ii) *other scientific leaders who are of-*
12 *ficers or employees of NIH and are not*
13 *members of the Board;*

14 “(iii) *advisory councils of the national*
15 *research institutes and national centers;*

16 “(iv) *organizations representing the*
17 *scientific community; and*

18 “(v) *organizations representing pa-*
19 *tients.*

20 “(3) *COMPOSITION OF BOARD.—The Board shall*
21 *consist of the Director of NIH, who shall be a perma-*
22 *nent nonvoting member on an ex officio basis, and an*
23 *odd number of additional members, not to exceed 21,*
24 *all of whom shall be voting members. The voting*
25 *members of the Board shall be the following:*

1 “(A) Not fewer than 9 officials who are di-
2 rectors of national research institutes or national
3 centers. The Secretary shall designate such offi-
4 cials for membership and shall ensure that the
5 group of officials so designated includes directors
6 of—

7 “(i) national research institutes whose
8 budgets are substantial relative to a major-
9 ity of the other institutes;

10 “(ii) national research institutes whose
11 budgets are small relative to a majority of
12 the other institutes;

13 “(iii) national research institutes that
14 have been in existence for a substantial pe-
15 riod of time without significant organiza-
16 tional change under subsection (d);

17 “(iv) as applicable, national research
18 institutes that have undergone significant
19 organization changes under such subsection,
20 or that have been established under such
21 subsection, other than national research in-
22 stitutes for which such changes have been in
23 place for a substantial period of time; and

24 “(v) national centers.

1 “(B) *Members appointed by the Secretary*
2 *from among individuals who are not officers or*
3 *employees of the United States. Such members*
4 *shall include—*

5 “(i) *individuals representing the inter-*
6 *ests of public or private institutions of high-*
7 *er education that have historically received*
8 *funds from NIH to conduct research; and*

9 “(ii) *individuals representing the in-*
10 *terests of private entities that have received*
11 *funds from NIH to conduct research or that*
12 *have broad expertise regarding how the Na-*
13 *tional Institutes of Health functions, exclu-*
14 *sive of private entities to which clause (i)*
15 *applies.*

16 “(4) *CHAIR.—The Chair of the Board shall be se-*
17 *lected by the Secretary from among the members of*
18 *the Board appointed under paragraph (3)(B). The*
19 *term of office of the Chair shall be 2 years.*

20 “(5) *MEETINGS.—*

21 “(A) *IN GENERAL.—The Board shall meet*
22 *at the call of the Chair or upon the request of the*
23 *Director of NIH, but not fewer than 5 times with*
24 *respect to issuing any particular report under*
25 *paragraph (2)(A). The location of the meetings of*

1 *the Board is subject to the approval of the Direc-*
2 *tor of NIH.*

3 “(B) *PARTICULAR FORUMS.*—*Of the meet-*
4 *ings held under subparagraph (A) with respect*
5 *to a report under paragraph (2)(A)—*

6 “(i) *one or more shall be directed to-*
7 *ward the scientific community to address*
8 *scientific needs and opportunities related to*
9 *proposals for organizational changes under*
10 *subsection (d), or as the case may be, re-*
11 *lated to a proposal that no such changes be*
12 *made; and*

13 “(ii) *one or more shall be directed to-*
14 *ward consumer organizations to address the*
15 *needs and opportunities of patients and*
16 *their families with respect to proposals re-*
17 *ferred to in clause (i).*

18 “(C) *AVAILABILITY OF INFORMATION FROM*
19 *FORUMS.*—*For each meeting under subparagraph*
20 *(B), the Director of NIH shall post on the Inter-*
21 *net site of the National Institutes of Health a*
22 *summary of the proceedings.*

23 “(6) *COMPENSATION; TERM OF OFFICE.*—*The*
24 *provisions of subsections (b)(4) and (c) of section 406*
25 *apply with respect to the Board to the same extent*

1 *and in the same manner as such provisions apply*
2 *with respect to an advisory council referred to in such*
3 *subsections, except that the reference in such sub-*
4 *section (c) to 4 years regarding the term of an ap-*
5 *pointed member is deemed to be a reference to 5*
6 *years.*

7 “(7) *REPORTS.—*

8 “(A) *RECOMMENDATIONS FOR CHANGES.—*

9 *Each report under paragraph (2)(A) shall be*
10 *submitted to—*

11 “(i) *the Committee on Energy and*
12 *Commerce and the Committee on Appro-*
13 *propriations of the House of Representatives;*

14 “(ii) *the Committee on Health, Edu-*
15 *cation, Labor, and Pensions and the Com-*
16 *mittee on Appropriations of the Senate;*

17 “(iii) *the Secretary; and*

18 “(iv) *officials with organizational au-*
19 *thorities, other than any such official who*
20 *served as a member of the Board with re-*
21 *spect to the report involved.*

22 “(B) *AVAILABILITY TO PUBLIC.—The Direc-*
23 *tor of NIH shall post each report under para-*
24 *graph (2) on the Internet site of the National In-*
25 *stitutes of Health.*

1 “(C) *REPORT ON BOARD ACTIVITIES.*—Not
2 *later than 18 months after the date of the enact-*
3 *ment of the National Institutes of Health Reform*
4 *Act of 2006, the Board shall submit to the com-*
5 *mittees specified in subparagraph (A) a report*
6 *describing the activities of the Board.*

7 “(f) *ORGANIZATIONAL CHANGES PER RECOMMENDA-*
8 *TION OF SCIENTIFIC MANAGEMENT REVIEW BOARD.*—

9 “(1) *IN GENERAL.*—With respect to an official
10 *who has organizational authorities within the mean-*
11 *ing of subsection (e)(2)(A), if a recommendation to*
12 *the official for an organizational change is made in*
13 *a report under such subsection, the official shall, ex-*
14 *cept as provided in paragraphs (2), (3), and (4) of*
15 *this subsection, make the change in accordance with*
16 *the following:*

17 “(A) *Not later than 100 days after the re-*
18 *port is submitted under subsection (e)(7)(A), the*
19 *official shall initiate the applicable public proc-*
20 *ess required in subsection (d) toward making the*
21 *change.*

22 “(B) *The change shall be fully implemented*
23 *not later than the expiration of the 3-year period*
24 *beginning on the date on which such process is*
25 *initiated.*

1 “(2) *INAPPLICABILITY TO CERTAIN REORGANIZA-*
2 *TIONS.—Paragraph (1) does not apply to a rec-*
3 *ommendation made in a report under subsection*
4 *(e)(2)(A) if the recommendation is for—*

5 “(A) *an organizational change under sub-*
6 *section (d)(2) that constitutes the establishment,*
7 *termination, or consolidation of one or more na-*
8 *tional research institutes or national centers; or*

9 “(B) *an organizational change under sub-*
10 *section (d)(3).*

11 “(3) *OBJECTION BY DIRECTOR OF NIH.—*

12 “(A) *IN GENERAL.—Paragraph (1) does not*
13 *apply to a recommendation for an organiza-*
14 *tional change made in a report under subsection*
15 *(e)(2)(A) if, not later than 90 days after the re-*
16 *port is submitted under subsection (e)(7)(A), the*
17 *Director of NIH submits to the committees speci-*
18 *fied in such subsection a report providing that*
19 *the Director objects to the change, which report*
20 *includes the reasons underlying the objection.*

21 “(B) *SCOPE OF OBJECTION.—For purposes*
22 *of subparagraph (A), an objection by the Direc-*
23 *tor of NIH may be made to the entirety of a rec-*
24 *ommended organizational change or to 1 or more*
25 *aspects of the change. Any aspect of a change not*

1 *objected to by the Director in a report under sub-*
2 *paragraph (A) shall be implemented in accord-*
3 *ance with paragraph (1).*

4 “(4) *CONGRESSIONAL REVIEW.*—*An organiza-*
5 *tional change under subsection (d)(2) that is initiated*
6 *pursuant to paragraph (1) shall be carried out by*
7 *regulation in accordance with the procedures for sub-*
8 *stantive rules under section 553 of title 5, United*
9 *States Code. A rule under the preceding sentence shall*
10 *be considered a major rule for purposes of chapter 8*
11 *of such title (relating to congressional review of agen-*
12 *cy rulemaking).*

13 “(g) *DEFINITIONS.*—*For purposes of this title:*

14 “(1) *The term ‘Director of NIH’ means the Di-*
15 *rector of the National Institutes of Health.*

16 “(2) *The terms ‘national research institute’ and*
17 *‘national center’ mean an agency of the National In-*
18 *stitutes of Health that is—*

19 “(A) *listed in subsection (b) and not termi-*
20 *nated under subsection (d)(2)(A); or*

21 “(B) *established by the Director of NIH*
22 *under such subsection.*

23 “(h) *REFERENCES TO NIH.*—*For purposes of this*
24 *title, a reference to the National Institutes of Health in-*
25 *cludes its agencies.”.*

1 (c) *CONFORMING AMENDMENTS.*—*Title IV of the Pub-*
2 *lic Health Service Act (42 U.S.C. 281 et seq.) is amended—*

3 (1) *by redesignating subpart 3 of part E as sub-*
4 *part 19;*

5 (2) *by transferring subpart 19, as so redesi-*
6 *gnated, to part C of such title IV;*

7 (3) *by inserting subpart 19, as so redesignated,*
8 *after subpart 18 of such part C; and*

9 (4) *in subpart 19, as so redesignated—*

10 (A) *by redesignating section 485B as section*
11 *464z-1;*

12 (B) *by striking “National Center for*
13 *Human Genome Research” each place such term*
14 *appears and inserting “National Human Ge-*
15 *nome Research Institute”;* and

16 (C) *by striking “Center” each place such*
17 *term appears and inserting “Institute”.*

18 **SEC. 102. AUTHORITY OF DIRECTOR OF NIH.**

19 (a) *SECRETARY ACTING THROUGH THE DIRECTOR.*—
20 *Section 402(b) of the Public Health Service Act (42 U.S.C.*
21 *282(b)) is amended—*

22 (1) *by redesignating paragraph (14) as para-*
23 *graph (22);*

24 (2) *by striking paragraphs (12) and (13);*

1 (3) by redesignating paragraphs (4) through (11)
2 as paragraphs (14) through (21);

3 (4) in paragraph (21) (as so redesignated), by
4 inserting “and” after the semicolon at the end;

5 (5) in the matter after and below paragraph (22)
6 (as so redesignated), by striking “paragraph (6)” and
7 inserting “paragraph (16)”; and

8 (6) by striking “the Secretary” in the matter
9 preceding paragraph (1) and all that follows through
10 paragraph (1) and inserting the following: “the Sec-
11 retary, acting through the Director of NIH—

12 “(1) shall carry out this title, including being re-
13 sponsible for the overall direction of the National In-
14 stitutes of Health and for the establishment and im-
15 plementation of general policies respecting the man-
16 agement and operation of programs and activities
17 within the National Institutes of Health;”.

18 (b) *ADDITIONAL AUTHORITIES.*—Section 402(b) of the
19 Public Health Service Act, as amended by subsection (a)
20 of this section, is amended by striking paragraphs (2) and
21 (3) and inserting the following:

22 “(2) shall coordinate and oversee the operation of
23 the national research institutes, national centers, and
24 administrative entities within the National Institutes
25 of Health;

1 “(3) shall, in consultation with the heads of the
2 national research institutes and national centers, be
3 responsible for program coordination across the na-
4 tional research institutes and national centers, in-
5 cluding conducting priority-setting reviews, to ensure
6 that the research portfolio of the National Institutes
7 of Health is balanced and free of unnecessary duplica-
8 tion, and takes advantage of collaborative, cross-cut-
9 ting research;

10 “(4) shall assemble accurate data to be used to
11 assess research priorities, including information to
12 better evaluate scientific opportunity, public health
13 burdens, and progress in reducing health disparities;

14 “(5) shall ensure that scientifically based stra-
15 tegic planning is implemented in support of research
16 priorities as determined by the agencies of the Na-
17 tional Institutes of Health;

18 “(6) shall ensure that the resources of the Na-
19 tional Institutes of Health are sufficiently allocated
20 for research projects identified in strategic plans;

21 “(7)(A) shall, through the Division of Program
22 Coordination, Planning, and Strategic Initiatives—

23 “(i) identify research that represents impor-
24 tant areas of emerging scientific opportunities,
25 rising public health challenges, or knowledge

1 *gaps that deserve special emphasis and would*
2 *benefit from conducting or supporting additional*
3 *research that involves collaboration between 2 or*
4 *more national research institutes or national*
5 *centers, or would otherwise benefit from strategic*
6 *coordination and planning;*

7 *“(ii) include information on such research*
8 *in reports under section 403; and*

9 *“(iii) in the case of such research supported*
10 *with funds referred to in subparagraph (B)—*

11 *“(I) require as appropriate that pro-*
12 *posals include milestones and goals for the*
13 *research;*

14 *“(II) require that the proposals include*
15 *timeframes for funding of the research; and*

16 *“(III) ensure appropriate consider-*
17 *ation of proposals for which the principal*
18 *investigator is an individual who has not*
19 *previously served as the principal investi-*
20 *gator of research conducted or supported by*
21 *the National Institutes of Health;*

22 *“(B) may, with respect to funds reserved under*
23 *section 402A(c)(1) for the Common Fund, allocate*
24 *such funds to the national research institutes and na-*

1 *tional centers for conducting and supporting research*
2 *that is identified under subparagraph (A); and*

3 *“(C) may assign additional functions to the Di-*
4 *vision in support of responsibilities identified in sub-*
5 *paragraph (A), as determined appropriate by the Di-*
6 *rector;*

7 *“(8) shall, in coordination with the heads of the*
8 *national research institutes and national centers, en-*
9 *sure that such institutes and centers—*

10 *“(A) preserve an emphasis on investigator-*
11 *initiated research project grants, including with*
12 *respect to research involving collaboration be-*
13 *tween 2 or more such institutes or centers; and*

14 *“(B) when appropriate, maximize investi-*
15 *gator-initiated research project grants in their*
16 *annual research portfolios;*

17 *“(9) shall ensure that research conducted or sup-*
18 *ported by the National Institutes of Health is subject*
19 *to review in accordance with section 492 and that,*
20 *after such review, the research is reviewed in accord-*
21 *ance with section 492A(a)(2) by the appropriate advi-*
22 *sory council under section 406 before the research pro-*
23 *posals are approved for funding;*

1 “(10) shall have authority to review and approve
2 the establishment of all centers of excellence rec-
3 ommended by the national research institutes;

4 “(11)(A) shall oversee research training for all of
5 the national research institutes and National Re-
6 search Service Awards in accordance with section
7 487; and

8 “(B) may conduct and support research
9 training—

10 “(i) for which fellowship support is not pro-
11 vided under section 487; and

12 “(ii) that does not consist of residency
13 training of physicians or other health profes-
14 sionals;

15 “(12) may, from funds appropriated under sec-

16 *2006.*—A State shall use amounts redistributed
17 under this subsection only for expenditures for
18 providing child health assistance or other health
19 benefits coverage for populations eligible for such
20 assistance or benefits under the State child
21 health plan (including under a waiver of such
22 plan) on October 1, 2006.

23 “(B) *REGULAR FMAP FOR EXPENDITURES*
24 *FOR COVERAGE OF NONCHILD POPULATIONS.*—To
25 the extent a State uses amounts redistributed

1 under this subsection for expenditures for pro-
2 viding child health assistance or other health
3 benefits coverage to an individual who is not a
4 child or a pregnant woman, the Federal medical
5 assistance percentage (as defined in the first sen-
6 tence of section 1905(b)) applicable to the State
7 for the fiscal year shall apply to such expendi-
8 tures for purposes of making payments to the
9 State under subsection (a) of section 2105 from
10 such amounts.

11 “(5) *RETROSPECTIVE ADJUSTMENT.*—

12 “(A) *IN GENERAL.*—The Secretary may ad-
13 just the estimates and determinations made
14 under paragraphs (1), (2), and (3) as necessary
15 on the basis of the amounts reported by States
16 not later than November 30, 2007, on CMS
17 Form 64 or CMS Form 21, as the case may be
18 and as approved by the Secretary, but in no case
19 may the applicable amount described in para-
20 graph (3)(C)(ii) exceed the amount determined
21 by the Secretary on the basis of the most recent
22 data available to the Secretary as of March 31,
23 2007.

24 “(B) *FUNDING OF ANY RETROSPECTIVE AD-*
25 *JUSTMENTS ONLY FROM UNEXPENDED 2005 AL-*

1 *LOTMENTS.—Notwithstanding subsections (e)*
2 *and (f), to the extent the Secretary determines it*
3 *necessary to adjust the estimates and determina-*
4 *tions made for purposes of paragraphs (1), (2),*
5 *and (3), the Secretary may use only the allot-*
6 *ments for fiscal year 2005 under subsection (b)*
7 *that remain unexpended through the end of fiscal*
8 *year 2007 for providing any additional amounts*
9 *to States described in paragraph (2)(B) (without*
10 *regard to whether such unexpended allotments*
11 *are from States described paragraph (3)(B)).*

12 *“(C) RULES OF CONSTRUCTION.—Nothing*
13 *in this subsection shall be construed as—*

14 *“(i) authorizing the Secretary to use*
15 *the allotments for fiscal year 2006 or 2007*
16 *under subsection (b) of States described in*
17 *paragraph (3)(B) to provide additional*
18 *amounts to States described in paragraph*
19 *(2)(B) for purposes of eliminating the fund-*
20 *ing shortfall for such States for fiscal year*
21 *2007; or*

22 *“(ii) limiting the authority of the Sec-*
23 *retary to redistribute the allotments for fis-*
24 *cal year 2005 under subsection (b) that re-*
25 *main unexpended through the end of fiscal*

1 year 2007 and are available for redistribu-
2 tion under subsection (f) after the applica-
3 tion of subparagraph (B).

4 “(6) 1-YEAR AVAILABILITY; NO FURTHER REDIS-
5 TRIBUTION.—Notwithstanding subsections (e) and (f),
6 amounts redistributed to a State pursuant to this
7 subsection for fiscal year 2007 shall only remain
8 available for expenditure by the State through Sep-
9 tember 30, 2007, and any amounts of such redistribu-
10 tions that remain unexpended as of such date, shall
11 not be subject to redistribution under subsection (f).
12 Nothing in the preceding sentence shall be construed
13 as limiting the ability of the Secretary to adjust the
14 determinations made under paragraphs (1), (2), and
15 (3) in accordance with paragraph (5).

16 “(7) DEFINITION OF STATE.—For purposes of
17 this subsection, the term ‘State’ means a State that
18 receives an allotment for fiscal year 2007 under sub-
19 section (b).”.

20 (b) EXTENDING AUTHORITY FOR QUALIFYING STATES
21 TO USE CERTAIN FUNDS FOR MEDICAID EXPENDITURES.—
22 Section 2105(g)(1)(A) of such Act (42 U.S.C.
23 1397ee(g)(1)(A)) is amended by striking “or 2005” and in-
24 serting “2005, 2006, or 2007”.

1 (c) *REPORT TO CONGRESS.*—Not later than April 30,
2 2007, the Secretary of Health and Human Services shall
3 submit a report to the Committee on Energy and Commerce
4 of the House of Representatives and the Committee on Fi-
5 nance of the Senate regarding the amounts redistributed to
6 States under section 2104 of the Social Security Act to re-
7 duce funding shortfalls for the State Children’s Health In-
8 surance Program (SCHIP) for fiscal year 2007. Such re-
9 port shall include descriptions and analyses of—

10 (1) *the extent to which such redistributed*
11 *amounts have reduced or eliminated such shortfalls on*
12 *the basis of reports by States submitted to the Sec-*
13 *retary as of April 1, 2007; and*

14 (2) *the effect of the redistribution and limited*
15 *availability of unexpended fiscal year 2005 allotments*
16 *under such program on the States described in section*
17 *2104(h)(3)(B) of the Social Security Act (42 U.S.C.*
18 *1397dd(h)(3)(B)) on the basis of reports by States*
19 *submitted to the Secretary as of such date.*
